About the Canada Summer Jobs Program

Objectives of the Canada Summer Jobs Program

Canada Summer Jobs is an initiative of the Youth Employment Strategy, which is the Government of Canada's commitment to help young people between the ages of 16 and 30, particularly those facing barriers to employment, get the information and gain the skills, work experience and abilities they need to transition successfully into the labour market.

The program provides wage subsidies to employers from not-for-profit organizations, the public-sector, and private sector organizations with 50 or fewer full-time employees, to create quality summer work experiences for young people aged 16 to 30 years.

In delivering on these objectives, the Government of Canada aims to ensure that youth job opportunities funded by the program take place in an environment that respects the rights of all Canadians.

These youth summer work experiences represent important pathways facilitating future transitions to the workforce.

Responsibilities include but are not limited to:

- Support music classes by assisting educators in delivering lessons and activities.
- Contribute to creating a safe, inclusive, and engaging learning environment.
- Collaborate with staff to organize performances and activities.
- Foster an inclusive environment where all students feel welcome, accepted, and supported.
- Welcome students and/or prepare for concerts in the morning

The successful candidate must:

- Have experience working with school-aged children (an asset but not required).
- Demonstrate excellent time management skills.
- Be capable of leading small groups of participants.
- Exhibit strong organizational skills and flexibility.
- Be between 18 and 30 years of age at the start of employment.
- Be a Canadian citizen, permanent resident, or person to whom refugee protection has been conferred under the Immigration and Refugee Protection Act for the duration of the employment
- Have a valid Social Insurance Number at the start of employment and be legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations.
